If cost to close open or expired building permits or to remedy any permit violation of any governmental entity exceeds Permit Limit, then within 5 days after a party's receipt of estimates of cost to remedy: (A) Seller may elect to pay the excess by delivering written notice to Buyer; or (B) Buyer may deliver written notice to Seller accepting the Property in its "as is" condition with regard to building permit status and agreeing to receive credit from Seller at Closing in the amount of Permit Limit. If neither party delivers such written notice to the other, then either party may terminate this Contract and Buyer shall be refunded the Deposit, thereby releasing Buyer and Seller from all further obligations under this Contract.

(ii) TITLE EXAMINATION: Buyer shall have 5 days after receipt of Title Commitment to examine it and notify 406 Seller in writing specifying defect(s), if any, that render title unmarketable. If Seller provides Title Commitment and it 407 is delivered to Buyer less than 5 days prior to Closing Date, Buyer may extend Closing for up to 5 days after 408 date of receipt to examine same in accordance with this STANDARD A. Seller shall have 30 days ("Cure Period") 409 after receipt of Buyer's notice to take reasonable diligent efforts to remove defects. If Buyer fails to so notify Seller, 410 Buyer shall be deemed to have accepted title as it then is. If Seller cures defects within Cure Period, Seller will 411 deliver written notice to Buyer (with proof of cure acceptable to Buyer and Buyer's attorney) and the parties will 412 close this Contract on Closing Date (or if Closing Date has passed, within 10 days after Buyer's receipt of Seller's 413 notice). 
